9.2 Lot 500 (No.26) Wood Street, Inglewood, Perth - Built Strata to Create23 Strata Lots for Existing Apartments, with One Strata Lot Including Substantial Area of Current Common Property

Members discussed the item and agreed to endorse the Officer's recommendation.

Moved by Ms Adair Seconded by Mr Holloway

That the Statutory Planning Committee (SPC) resolves to approve the application for the built strata plan of Lot 500 Wood Street, Inglewood as shown on the plan date-stamped 23 March 2017, subject to the following conditions:

CONDITIONS:

- The built strata plan being modified as per the lot boundaries marked on the attached plans date-stamped 8 August 2017 by the Department of Planning, Lands and Heritage. (Western Australian Planning Commission)
- 2. Written confirmation from the local government that all necessary local government approval(s) have been issued and that the whole of the building has been completed in accordance with those approvals. (Local Government)
- Measures being taken to ensure the identification and protection of any vegetation on the site worthy of retention that is not impacted by the built strata plan works, prior to commencement of works. (Local Government)
- 4. Arrangements being made with the Water Corporation that provision of a suitable water supply service will be available to the lots shown on the approved plan of subdivision. (Water Corporation)
- 5. Arrangements being made with the Water Corporation so that provision of a sewerage service will be available to the lots shown on the approved plan of subdivision. (Water Corporation)

- 6. Arrangements being made to the satisfaction of the Western Australian Planning Commission and to the specification of Western Power, for the provision of an electricity supply service to the survey strata lot(s) shown on the approved plan of subdivision, which may include the provision of necessary service access rights either as an easement under Section 136C and Schedule 9A of the Transfer of Land Act 1893 for the transmission of electricity by underground cable, or (in the case of approvals containing common property) via a portion of the common property suitable for consumer mains. (Western Power)
- 7. The transfer of land as a Crown reserve free of cost to Western Power for the provision of electricity supply infrastructure. (Western Power).

ADVICE:

- 1. In regard to Conditions 4 and 5, the landowner/applicant shall make arrangements with the Water Corporation for the provision of the necessary services. On receipt of a request from the landowner/applicant, a Land Development Agreement under Section 83 of the Water Services Act 2012 will be prepared by the Water Corporation to document the specific requirements for the proposed subdivision.
- 2. In regard to Condition 6, Western Power provides only one underground point of electricity supply per freehold lot.
