7. Deputations and presentations

7.1 City of Stirling - Local Planning Scheme No. 3, Amendment No. 124 - Certification to advertise

Presenters: Gareth Glanville - City of Stirling

Mr Glanville presented to the Statutory Planning Committee on behalf of the City of Stirling to provide background to the amendment, which seeks to bring planning control back to the City through collaboration with the Department of Planning, Lands and Heritage (DPLH) and DevelopmentWA, in order to collect contributions towards the foreshore

and works east of West Coast Highway. Mr Glanville stated that the City is supportive of the recommendation before the Committee.

Mr Glanville responded to questions from members in relation to the dual operation of the DevelopmentWA Scheme and the City's Scheme, while the City's new Scheme is prepared. Mr Glanville stated that the City's new Scheme is not expected in the near future, but noted that the City is meeting with the DPLH in the coming months to begin developing the scope for changes required between the current and new Scheme.

8.3 Town of Mosman Park Local Planning Scheme No. 3, Amendment No. 2 – Certification to Advertise (TPS/2849)

Mr Caddy declared a Perceived Impartiality Interest on this item and left the meeting at 10:19am.

The nominated Chairperson, Mr Davies, presided over the meeting in the absence of Mr Caddy.

Members discussed the age of the Town of Mosman Park's Local Planning Scheme and Strategy, and the ad-hoc nature of the proposed Amendment. Members were advised that the Town's Report of Review is not due until 2023, however, the DPLH has recommended that the Town bring forward the Report of Review. Members discussed the Scheme review timeline, and raised concern with potential negative outcomes for important strategic projects arising whilst a new Scheme and Strategy is being prepared. Members sought clarification of Clause 37(5) of the Planning and Development (Local Planning Scheme) Regulations 2015.

Members agreed to endorse the recommendation of the Department of Planning, Lands and Heritage.

That the Statutory Planning Committee resolves to:

 Consider that modification of Amendment No. 2 to the Town of Mosman Park Local Planning Scheme No. 3 is required for it to be suitable for advertising, to achieve conformance with the Planning and Development (Local Planning Schemes) Regulations 2015, in accordance with the attached schedule of modifications (Attachment 5 – Schedule of Modifications).

Upon completion of these modifications, the scheme amendment is to be advertised in accordance with regulation 38 of the Planning and Development (Local Planning Schemes) Regulations 2015; and

- 2. Advise Council of the following:
 - The amendment area is not identified as an area for intensification under the Central Sub-regional Planning
 Framework, and is inconsistent with the WAPC endorsed Local Planning Strategy. Further justification is to be provided with the amendment when submitted for final approval to demonstrate that the proposed density change is appropriate in the absence of a broader strategic planning review;

• The Town is to provide the necessary level of supporting information in accordance with State Planning Policy 3.7 -Planning In Bushfire Prone Areas when referring the Scheme amendment to the Department of Fire and Emergency Services, and upon resubmittal to the WAPC for a final recommendation to the Minister.
